Bohol Public School Teachers and Employees Multi-Purpose Cooperative

2020 BPSTEMPC ELECTION GUIDELINES

- Pursuant to Article IV, Section 5 of the Amended by-Laws, the 57th Annual General Assembly is set on March 22, 2020 at the Bohol Cultural Center, City of Tagbilaran.
- 2. In accordance with the Constitution and By-Laws, and Election Guidelines of the Cooperative, the following information is issued for your information and guidance.
- 3. Only members in good standing (MIGS) are qualified to attend to the said General Assembly on the scheduled date. To be considered MIGS, a member must:
 - a. have at least one (1) year membership with the BPSTEMPC;
 - no past due accounts on or before December 28, 2019;
 - borrowed at least Php 10,000.00 on or before December 28, 2019;
 - d. have a fixed deposit of at least Php 5,000.00 and savings deposit of at least Php 1,000.00 on or before December 28, 2019:
 - e. candidates for the board of directors must have a fix deposit of at least Php100,000.00 and savings of Php50,000.00 and borrowed at least Php50, 000,00 on or before December 28, 2019
 - f. candidates for the committee must have a fix deposit of at least Php50, 000.00 and savings deposit of at least Php 5,000.00 and borrowed at least Php 20,000.00 on or before December 28,
 - g. Elected and appointed officers of the cooperative must attend the required mandatory training by the Cooperative Development Authority during the first half of their term. Officers with hold over term must submit certificate of training conducted by the CDA accredited service provider. Sanction: Failure to comply letter (g) provision means disqualification for future election but can apply after compliance of the said requirements.
- 4. The filing of the Certificate of Candidacy shall start on January 17, 2020 and ends on February 15, 2020.
- The Campaign period will be on March 5, 2018 up to March 21, 2020. Distribution of propaganda materials at the venue on election day is strictly prohibited. Any violation will cause the disqualification of the candidate concerned.
- 6. Registration of delegates /members will start at 7:00 to 8:00 in the morning of the assembly day, March 22, 2020.
- 7. No proxy is allowed.
- All qualified delegates are allowed to vote.
- Only registered delegates are allowed to stay at the assembly hall.
- All MIGS are required to present their DepEd ID and or OSCA ID card.
- 11. Widest dissemination and compliance is hereby enjoined.
