The BAC shall assume no responsibility for the misplacement of the contents of the improperly sealed or marked bid for its premature opening.

The **Department of Education – Schools Division of Bohol** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
