- 1. To prepare the schools for the opening of School Year 2024-2025, this Office announces the conduct of Division Brigada Eskwela 2024 in all public schools in this division from July 23-27, 2024, with the theme, "Bayanihan para sa Matatag na Paaralan".
- 2. The implementation of the 2024 Brigada Eskwela shall follow the mechanics provided under D.O. 021, s. 2023 on the Brigada Eskwela Implementing Guidelines.
- 2. The Division Brigada Eskwela Kick-off Program shall be held on **July 23**, **2024**, **6:30 A.M.** at **Loay National High School**, **Loay District**. Likewise, there shall be a simultaneous Kick-off ceremonies and other advocacy activities to be done at their respective schools to launch the weeklong Brigada Eskwela implementation.
- 3. Participants to the Division Kick-off Program include school heads, teachers and personnel of host school/district, volunteers, other stakeholders and identified division personnel.

Schools must submit Brigada Eskwela Report through the **DepEd Partnerships Database System (DPDS)**.
- 5. As part of the Brigada Eskwela activities, *Brigada Opisina* shall also be observed in all offices of this division on July 26, 2024.
