- 1. Executive Order No. 29, s. 2017 mandates the observance of National Disaster Resilience Month (NDRM) by Filipinos throughout the country through the conduct of activities relative to building disaster resilience. It also states the shift of focus from disaster awareness building to the promotion of significant disaster resilience to adapt and to recover from the effects of hazards and disasters through effective risk management.
- 2. This year, this Office, directs all Offices and schools to mobilize our stakeholders during the Brigada Eskwela week on July 22-26, 2024 to do the following disaster preparedness measures to their respective schools:
 - a) Conduct risk assessment and hazard mapping;
 - b) Develop plans;
 - c) Inspect school buildings and infrastructure for the hazards and make necessary upgrades;
 - d) Distribution of IEC materials on disaster preparedness to learners and stakeholders;
 - Resource mobilization for the prepositioning of first aid kit, fire extinguishers, emergency go bag and other response supplies and equipment;
 - f) Organize Clean-up and tree growing activities; and
 - g) Other related activities to promote resiliency and well-being of the learners and personnel.
- 3. Furthermore, all School Heads and designated Non-teaching DRRM Coordinators are required to participate the Online Disaster Preparedness (HYDROMET, Volcano, Earthquake and Tsunami Hazards) and DepEd Disaster Response Program (Temporary Learning Spaces, Clean-up and Minor Repair, Temporary Wash Facility, Response Mobilization and Emergency Feeding) of the Department of Education on July 31, 2024 (8:00- AM-5:00 PM) at RO7 DRRM, MS Teams platform (link to be forwarded to the GC of Division DRRM Coordinators) before the scheduled time.
