
Greetings of peace and Prosperity for everyone!!!

However, due to the uncontrolled circumstances encountered since the beginning until the present situation, it is impossible for us to complete the delivery of the required volume on the period stated in the contract/Purchase Order. Thus, we sincerely request for an extension on the period of delivery of the milk ration from May 30, 2024 to the month of July, 2024 or until July 31, 2024. The uncontrolled circumstances that caused delay in the production and delivery of the milk ration include:


- a) Decreasing milk supply due to shortage of forages and declining water supply/source as affected by the El Niño phenomenon
- b) Uncontrolled breakdown of processing equipment which lessens our daily processing output
- c) Fluctuation on electrical supply that caused abnormal cooling of the existing storage facility and storage equipment

We sincerely give our apology for any unfavorable situations brought about by this situation. We assure you of our full commitment to diligently comply to the program requirements.
